Evenings with Experts - Free public lecture series at the Cambridge Public Library featuring experts on native plant landscapes and ecological land stewardship. These events are free and open to all. Videos are created of these lectures and are posted on our website. Combined, these lectures and videos reach over 1,500 people each year.

Native Plant Sale - Once a year, we work with 10 different nurseries to offer more than 130 species of native plants to the public. This encourages the public to buy native plants and helps build a stronger demand for natives within the nursery industry, promoting an ecological shift in growing practices.
